Club Accomplishments

Dancing With Wolves continues to produce boast some of the highest-ranking amateur dancers in the country. Two couples who competed in the Nationals were named National Champions for Latin in the Gold and Silver levels. In Standard, an NCSU couple was named runner-up in Silver Standard and an NCSU affiliate won Gold Standard. In both Latin and Standard, NCSU couples repeatedly advanced through multiple rounds of intense elimination, making it to finals.

DWW dancers also performed admirably at competitions in the rest of the season, beginner dancers making call-backs and advancing to finals at both beginner competitions, and the team holding its own against much larger teams from up north (traditionally a ballroom stronghold), when we ventured to competitions like DCDI, one of the largest collegiate competitions in the country – we sent over 50 competitors to the competition this year.
